I, the undersigned Participant, agree to defend, indemnify, and hold harmless HBSC Partners, LLC and the City of Huntington Beach, its officers, agents and employees (collectively referred to hereinafter as "HBSC") from and against any and all claims, demands, causes of action, or liabilities for damages, personal injury, death or property damage, arising, in whole or in part, directly or indirectly, from my entry onto the Huntington Beach Sports Complex or from my participation in activities at the Huntington Beach Sports Complex, except as may arise from the gross negligence or willful misconduct of HBSC. In any action or claim against HBSC in which Participant is defending HBSC, HBSC shall have the right to approve legal counsel providing HBSC's defense and such approval shall not be unreasonably withheld.

I further agree to release HBSC from any and all claims for any damages, including property damage, injury, illness, or death occurring or arising out of use of the Sports Complex, except as may be caused by the HBSC's gross negligence or willful misconduct. I agree to abide by the Sports Complex Rules and Regulations and acknowledge having received a copy thereof. Further, I agree that I will be held financially responsible for any damage to the Sports Complex or equipment, which is caused by my activities. I understand that **using the batting cages, playing soccer, baseball/softball**, and similar activities are hazardous recreational activities and may subject me to risk of injury or death. I further understand that the HBSC is not responsible in any way for determining whether my skill level is sufficient to conduct such activities in a safe manner and that I assume all such risk of injury or death.
